



Terms and Conditions of the Cell C Uber Rider Discount Promotion

1. General

- 1.1 It is important that you understand and agree to these terms and conditions in order for you to participate in this Uber Rider Discount Promotion (the "**Promotion**").
- 1.2 All standard terms and conditions of Cell C Limited and Cell C Service Provider Company (Pty) Limited apply to this Promotion.
- 1.3 This Promotion is organised by Uber and Cell C Limited, registration number 1999/007722/06 ("**Cell C**"). The Uber Ride discount is sponsored by Uber.
- 1.4 This Promotion is open to all Cell C customers who are first time users of Uber and who comply with the Uber user Terms ("**Participants**") (<https://www.uber.com/legal/terms/za/>).
- 1.5 The Promotion will run from 6 December 2017 until 31 October 2018 ("the **Promotional period**").
- 1.6 You understand that all information (including these terms and conditions) relating to this Promotion published on any promotional or advertising material or on our website at any time before or during the incentive period will form part of the terms and conditions of entry. Cell C and Uber also have the right to withdraw this Promotion at any stage before the Promotional Period is over.

2. Promotion details

2.1 The Promotion will be available to all Participants for the Promotional Period.

2.2 Participation in the Promotion is limited to Participants in locations in South Africa where Uber is available.

2.3 Participants will get a R50.00 (fifty Rand) once-off Discount Code to use on their first Uber ride.

3. Entry

Promotion Codes

3.1 To redeem a code for the Promotion (a "Discount Code"), Participants must have the Uber app, must have a smartphone with GPS capability, have downloaded the Uber app or signed-up at <https://get.uber.com/sign-up/>, registered and have active internet connection.

3.3 If a Participants ride costs less than the R50.00 (fifty Rand) as per the Discount Code, the remaining amount cannot be rolled over. If the Participant's ride costs more than the R50.00 (fifty Rand) as per the Discount Code, the Participant will be liable for the full remaining balance of the ride, which shall be charged to the payment method attached to the Participant's Uber account.

3.4 The Discount Code may only be used once by each Participant and will be valid only for the Promotional Period

3.5 The Discount Code cannot be transferred, duplicated or sold and there is no cash value.

3.6 Successful redemption of a Discount Code is subject to the availability of Uber partner drivers.



3.7 The Discount Code is not cumulative and cannot be used in conjunction with other promotion codes.

3.8 It is important that you understand that all participants indemnify Cell C and Uber, its directors, affiliates, members, partners, employees, agents, consultants, suppliers, contractors and sponsors against any loss or damages, either direct, indirect, consequential or otherwise, arising from its participation in this Promotion.

3.9 Cell C and/or Uber may amend, modify or otherwise change these terms and conditions in its sole and absolute discretion on notice to you and the amended version will be displayed in the same media as these terms and conditions.
