

## Cell C Home Connecta Fibre Vumatel Black Friday Promotion Terms and Conditions

Last Update: November 2022

1. It is important that you understand and agree to these Terms and Conditions in order to participate in the Cell C Home Connecta Fibre Vumatel Black Friday Promotion (the “**Promotion**”).
2. All standard Terms and Conditions of Cell C Limited and Cell C Service Provider Company Proprietary Limited (together, “**Cell C**”) apply which terms and conditions can be found at <https://www.cellc.co.za/cellc/terms-conditions>
3. The Promotion will run from 25 November 2022 (“**Promotion Commencement Date**”) to 27 November 2022 (“**Promotion End Date**”). Cell C reserves the right to amend or withdraw the Promotion in its sole and absolute discretion.
4. The Promotion is only applicable to new Vumatel installations and reconnections. Customers that have signed up for Vumatel services prior to the Promotion Commencement Date through Cell C or any other Internet Service Provider do not qualify for the Promotion.
5. All Cell C Fibre Month-to-Month Standard Terms and Conditions apply, which terms and conditions can be found at <https://www.cellc.co.za/cellc/fibre>
6. Customers participating in the Promotion shall receive a 100% promotional discount on their monthly subscription fee for their first 3 (three) calendar months of service. For the avoidance of doubt the promotional discount of 100% shall not apply to the fourth month of service, or any month subsequent to the fourth month of service.
7. From the fourth month of service, the customer’s billing shall be amended to the promotional rate for the customer’s respective package, which rate can be found in the table under section 10 below.
8. The customer’s billing shall remain at the promotional rate until such time that the customer terminates, migrates, upgrades, or downgrades the respective fibre service with Cell C, at which time the customer shall no longer be eligible for the Promotion and the benefits outlined in these terms and conditions.
9. Should the customer breach these terms and conditions and / or those set out in the Cell C Fibre Month-to-Month Standard Terms and Conditions, Cell C reserves the right to revoke the Promotion benefits from such customer.
10. The Promotion shall only be applicable to customers signing up on one of the following packages. Any Fibre Network Operator and Package Name combination not listed below shall not qualify for the Promotion.
